Dear Breeder,

The Irish Moiled Cattle Society UK Annual General Meeting will be held virtually via Zoom on Thursday 6th August at 7.30 pm, immediately following the ROI AGM. Members are asked to register via Society's WhatsApp.

As previously agreed, the **election of Directors will take place during the ROI AGM. Directors will be elected jointly to both companies through a single voting process.**

Election of Directors – 2026

Directors are returned from three constituencies, with representation broadly proportionate to the number of breeding Irish Moiled cattle in each area.

Following review, the Board of Directors has agreed that representation shall be as follows: Northern Ireland – 8, Great Britain – 5 and Republic of Ireland – 5.

Members are invited to nominate candidates from within their own constituency.

Nominations are not required for serving Directors who have indicated their willingness to continue in office if re-elected. Should an election be required, voting shall be restricted to members within the relevant constituency.

Northern Ireland Constituency - Represented by 8 Directors

Dermot Gardiner and Michelle McCauley are due to retire in 2026.

Both have indicated their willingness to continue in office if re-elected.

There are currently two vacancies in the Northern Ireland Constituency, each for a three-year term.

Republic of Ireland Constituency - Represented by 5 Directors

Trevor Chadwick and Brian Dolan are due to retire in 2026. Both have indicated their willingness to continue in office if re-elected. There are currently three vacancies in the Republic of Ireland Constituency: two for a three-year term and one for a two-year term.

Great Britain Constituency - Represented by 5 Directors

Dan Bull and Lyn Arrowsmith are due to retire in 2026.

Both have indicated their willingness to continue in office if re-elected.

There are currently two vacancies in the Great Britain Constituency, each for a three-year term.

The approved nomination format is set out on the nomination form, which is available from the Breed Secretary. Any fully paid-up member wishing to nominate a Director must use the 2026 nomination form. Completed nomination forms must be returned to the Breed Secretary no later than Friday 3rd July 2026.
